

**AMENDMENT #2
TO
CONTRACT NUMBER VA-171023-ATM
BETWEEN THE
VIRGINIA INFORMATION TECHNOLOGIES AGENCY
ON BEHALF OF
THE COMMONWEALTH OF VIRGINIA
AND
AT&T MOBILITY NATIONAL ACCOUNTS LLC**

This Amendment No. 2 ("Amendment 2") is entered into as of March 7, 2019, 2019 (the "Amendment 2 Effective Date") by and between AT&T Mobility National Accounts LLC ("Supplier") and the Virginia Information Technologies Agency on behalf of the Commonwealth of Virginia ("VITA") (VITA and Supplier are, at times, referred to herein individually as a "Party" or together as the "Parties").

Section 1. Recitals.

1.1 Supplier and VITA entered into that certain Wireless Services and Equipment Contract No. VA-171023-ATM, dated November 13, 2017, as amended (the "Contract").

1.2 Supplier and VITA intend to make certain changes to the Contract in accordance with the terms and conditions of this Amendment 2.

Section 2. Agreement. In consideration of the recitals set forth in §1 of Amendment 2 above, which are hereby re-stated and agreed to by the Parties, and for valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Parties, Supplier and VITA hereby agree to amend the Contract pursuant to the terms and conditions of this Amendment 2. Unless otherwise defined, capitalized terms in this Amendment 2 have the meanings ascribed to them in the Contract.

Section 3. AT&T Passport® Packages. Supplier will provide VITA and its qualified users with the AT&T Passport® feature ("AT&T Passport") pursuant to the terms and conditions of the Contract, and this Amendment 2 including, without limitation, the Sales Information for AT&T Passport®, attached hereto and incorporated herein as Exhibit A. AT&T Passport (a) is NOT eligible for the MSC Service Discount; and (b) is available for the term of Contract. VITA acknowledges and agrees that AT&T Passport is subject to the terms and conditions set forth in the Sales Information attached hereto as Exhibit A. If there is any material conflict between the terms of the Sales Information and the terms of this Amendment 2, then the terms of this Amendment 2 take precedence solely to the extent those terms and conditions pertain to AT&T Passport.


