TO

This MODIFICATION No. 12 is an agreement between the Virginia Information Technologies Agency ("VITA"), pursuant to § 2.2-2012 of the *Code of Virginia* and on behalf of the Commonwealth of Virginia ("Commonwealth"), and Cellco Partnership, a Delaware general partnership d/b/a Verizon Wireless (hereinafter referred to as "Supplier" or "Verizon Wireless"). Once executed by both parties, this Modification is hereby incorporated into and made part of Contract VA-171023-CELL (the "Contract").


**2. This Modification documents both parties' agreement to extend the Term of the Contract through June 30, 2022.**
