This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as “State” or “Commonwealth” or “VITA” (Virginia Information Technologies Agency), and T-Mobile USA, Inc. hereinafter referred to as “Contractor” or “Supplier”, relating to the modification of Contract VA-151001-TMO, as amended. This Modification is hereby incorporated into and made an integral part of Agreement VA-151001-TMO.

1. The parties agree to delete the First Responder Voice services in its entirety from Exhibit A – Pricing as added pursuant to Modification #5 dated June 30, 2020.
2. The parties agree to delete the First Responder Mobile Internet Data services in its entirety from Exhibit A – Pricing as added pursuant to Modification #5 dated June 30, 2020.
3. The parties agree to add First Responder suite of services to Exhibit A – Pricing as attached hereto.
4. The parties agree to add Government Public Static IP Voice to Exhibit A – Pricing as attached hereto.
5. The parties agree to add Government Public Static IP Mobile Internet to Exhibit A – Pricing as attached hereto.







## FIRST RESPONDER SUITE OF SERVICES

**1. Underlying Agreement.** The First Responder Agency agrees to purchase wireless mobile Service and Devices from T-Mobile directly through VITA (customer of record) under a VITA owned and managed billing account number (“BAN”) and T-Mobile agrees to provide the Services and Devices to the First Responder Agency based on the prices listed below. The terms of the First Responder Agency’s purchase and use of the Services will be governed by Agreement No.: VA-151001-TMO between T-Mobile and VITA (“Master Agreement”).

(a) The pricing terms and conditions of the First Respond Service plans or the Master Agreement will not be modified or superseded by any terms and conditions in a VITA generated Purchase Order. Purchase Orders will have no force or effect other than to denote quantity, the products or services purchased, delivery destinations, requested delivery dates and any other information required by this Addendum.

**2. Term; Termination.** Unless terminated under the terms of this Section 2, the pricing terms and condition of the First Responder Service plans will continue, provided the Master Agreement is in effect. The pricing, terms and conditions of the First Responder Service plans may be terminated: (i) for cause pursuant to the terms of the Master Agreement; or (ii) upon mutual written agreement by the parties; or (iii) by VITA upon 30 days prior written notice to T-Mobile; or (iv) after April 1, 2030, the pricing, terms and conditions of the First Responder Service plans may also be terminated by T-Mobile upon 30 days prior written notice to VITA.

**3. Total Line Eligibility and Line Limits.** To be eligible, First Responder Agency must be a police, emergency medical technician (EMT), fire, or non-profit responder agency. VITA is eligible for a combined total of 51,335 lines of Service using either, or a combination of both, the \$0 and \$15 rate plans (“Line Limit”). Line Limits are based on number of personnel performing first responder functions as described in this Section 3 (“Qualifying Headcount”). By way of example only, Qualifying Headcount will include, but will not be limited to, firefighters, EMTs, police officers, and dispatchers, but will not include, by way of example only, maintenance staff and office staff. In its sole discretion, T-Mobile will review the VITA’s Line Limit based on VITA’s Qualifying Headcount. T-Mobile may request documentation from VITA relating to its Qualifying Headcount. T-Mobile may also re-verify VITA’s Qualifying Headcount on a regular basis during the Term of the Addendum. Changes in VITA’s Qualifying Headcount may affect VITA’s total Line Limit.

**4. Subsidized Rate Plans.** If VITA has existing lines of Service with T-Mobile that have subsidized devices with term commitments (“Subsidized Lines”), and VITA wishes to move these Subsidized Lines to these Connecting Heroes rate plans, VITA agrees to comply with the requirements of those subsidized rate plans, including, but not limited to reimbursement to T-Mobile for device subsidies, if applicable.

**General First Responder/ Connecting Heroes Terms and Condition**

\*First Responder plans (excluding Connecting Heroes) are restricted to qualifying state government, local government and tribal government fire, police, and EMS agencies who verify eligibility. Minimum qualification is meeting one of the following NAICS Codes [(i) Police Protection 922120, (ii) Fire Protection 922160, (iii) Ambulance Services 621910). Final eligibility determinations are in T-Mobile's discretion.

\*\*Connecting Heroes plans not eligible for any aggregate volume discount; \$15 price does not include applicable taxes, fees and surcharges. Video typically streams on smartphone/tablet at DVD quality (480p). Coverage not available in some areas and may be impacted by emergencies; check your response area. \*\*Connecting Heroes plans are restricted to qualifying state government, local government and tribal government fire, police, and EMS agencies who verify eligibility. Final eligibility determinations are in T-Mobile's discretion. Meeting one of the following NAICS Codes is required but is not the sole basis for eligibility: Police Protection 922120 Fire Protection 922160, Ambulance Safety Services 621910. Additionally, qualifying in one of the following subcategories is required:

- Police, fire, or emergency medical services first responders
- Public safety or law enforcement command -Police, sheriff, fire, or emergency medical services
- Police or fire chiefs and their staff -Police or fire field command
- Police or fire dispatch -911 call centers

#### **General Rate Plan Terms and Conditions**

On all T-Mobile plans, for the small fraction of customers using >50GB/mo., primary data usage must be on smartphone or tablet. Smartphone and tablet usage is prioritized over Mobile Hotspot Service (tethering) usage, which may result in higher speeds for data used on smartphones and tablets. Not all features available on all devices. Unlimited talk & text features for direct communications between 2 people. Not for extended international use; you must reside in the U.S. and primary usage must occur on our network. Device must register on our network before international use.

**Tethering:** Tethering at max 3G. Service may be terminated or restricted for excessive roaming.

**Data Stash:** Up to 20 GB of on-network data from past 12 months carries over to next billing cycle for as long as you maintain qualifying service. Coverage not available in some areas; we are not responsible for our partners' networks.

**Network Management:** Service may be slowed, suspended, terminated, or restricted for misuse, abnormal use, interference with our network or ability to provide quality service to other users, or significant roaming. See T-Mobile.com/OpenInternet for data management details.
