

**MODIFICATION #15  
TO  
CONTRACT NUMBER VA-171023-TMO  
BETWEEN THE  
COMMONWEALTH OF VIRGINIA  
AND  
T-MOBILE USA, INC**

This Modification No. 15 (“Modification”) is an agreement between the Virginia Information Technologies Agency (“VITA”), pursuant to § 2.2-2012 of the Code of Virginia and on behalf of the Commonwealth of Virginia (“Commonwealth”) and T-Mobile USA, Inc. (“Supplier”), to modify and amend Contract No. VA-171023-TMO (“Contract”) in accordance with the terms and conditions of this Modification. This Modification and any attachments thereto is, upon execution by VITA and Supplier (each a “Party” and, collectively, the “Parties”), incorporated into and made an integral part of the Contract.

1. The Parties hereby agree to extend the Contract on a month-by-month basis for up to 12 months, beginning June 30, 2025. The Commonwealth may terminate the Contract during that period for any reason, with 30-days written notice.
2. During the extension period, all Terms, Conditions, Level of Services, and Pricing shall continue unchanged. The Supplier shall make no agreements, outside of this Contract, that affect contract services or rates to Authorized Users of this Contract, or which could be construed as attempting to influence the outcome of the competitive process to replace this contract.
3. Upon, or prior to, expiration of this contract, the Supplier shall provide adequate information and assistance to transition to a new contract, or a contract with another supplier with whom VITA contracts with to provide similar services.

The foregoing is the complete and final expression of the parties’ agreement to modify Contract VA-171023-TMO and cannot be modified, except by a writing signed by duly authorized representatives of both parties.
