

**MODIFICATION NO. 1
TO
CONTRACT NUMBER VA-180621-LOGI
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
Logi Analytics**

This Modification No. 1 ("**Modification**") is an agreement between the Virginia Information Technologies Agency ("**VITA**"), pursuant to § 2.2-2012 of the *Code of Virginia* and on behalf of the Commonwealth of Virginia ("**Commonwealth**"), and Logi Analytics ("**Supplier**"), to modify and amend Contract No. VA-180621-LOGI ("**Contract**") in accordance with the terms and conditions of this Modification. This Modification and any attachments thereto is, upon execution by VITA and Supplier (each a "**Party**" and, collectively, the "**Parties**"), incorporated into and made an integral part of the Contract.

Capitalized terms used in this Modification have the meaning ascribed to them in the Contract unless otherwise defined in this Modification.

In consideration of the recitals set forth above, which are hereby restated and agreed to by the Parties, and for valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Parties, Supplier and VITA agree to amend the Contract as follows:

1. Logi Analytics was acquired on April 1, 2021 by insightsoftware, LLC (formerly known as GS Acquisitionco, Inc. dba insightsoftware, LLC). This change resulted in a name change, physical address, and FEIN;
2. In accordance with Contract, *Section 21, I. Assignment*, attached is the Novation Agreement to Contract VA-180621-LOGI; and
3. In accordance with Contract, *Section 21, P. Contract Administration*, the account manager has been changed to Amanda LeCain, Customer Account Manager, Amanda.lecain@insightsoftware.com; 801-389-3041.

The changes set forth in this Modification are effective immediately.

The foregoing is the complete and final expression of the agreement between Supplier and VITA to modify the Contract and cannot be modified, except by writing signed by duly authorized representatives of both parties.
