

MODIFICATION NO. 005G TO  
CONTRACT NO. VA-151028-MCI  
VIRGINIA INFORMATION TECHNOLOGIES AGENCY  
AND  
VERIZON BUSINESS NETWORK SERVICES LLC

This Modification No. 005G, effective as of the date of execution by VITA (“Modification Effective Date”), is between VIRGINIA INFORMATION TECHNOLOGIES AGENCY (“VITA”), on behalf of the Commonwealth of Virginia, and VERIZON BUSINESS NETWORK SERVICES LLC, on behalf of MCI Communications Services, LLC (individually and collectively, “Verizon”) (the “Supplier” or “Contractor”) (the “Supplier”).

WHEREAS, in Modification 5 of Contract Number VA-151028-MCI (the “Agreement”), Attachment 1, the parties incorporated the following Exhibits:

- Exhibit 4.0 Pricing and Financial Provisions
- Exhibit 4.1 Pricing and Volumes Matrix,

WHEREAS, the parties desire to clarify language in Attachment 1, Ex. 4.0 and 4.1 of the Agreement pertaining to the payment of Milestones accepted after the Commencement Date

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, and of other good and valid consideration, the receipt and sufficiency of which are hereby acknowledged, VITA and Supplier agree to modify Attachment 1 to Modification No. 5 to Contract Number VA-151028-MCI (the “Attachment 1”) as follows:

1. Exhibit 4.0 - Pricing and Financial Provisions. Exhibit 4.0 is deleted in its entirety and replaced with the attached Revised Exhibit 4.0 (Pricing and Financial Provisions). The only changes in Revised Exhibit 4.0 are the following:
  - Section 3 Milestone Charges
    - Added 3.4 that states “VITA and Supplier agree that the remaining monthly installments for Milestones 2, 8, 14, 15, 18, 19 and 21 will be paid by VITA in one lump sum payment on or before July 1, 2022, totaling \$2,882,043.22. Payment terms for Milestones 25 through 29 will follow the previous payment agreement for milestones between VITA and Supplier, unless otherwise updated at a future time.”
2. Exhibit 4.1 - Pricing and Volume Matrix. Exhibit 4.1 is deleted in its entirety and replaced with the attached Revised Exhibit 4.1 (Pricing and Volumes Matrix). The only changes in Revised Exhibit 4.1 are the following:
  - Exhibit 4.1, Tab 6 – Milestone Charges
    - Added the statement “VITA and Supplier agree that the remaining monthly installments for Milestones 2, 8, 14, 15, 18, 19 and 21 will be paid by VITA in one lump sum payment on or before July 1, 2022, totaling \$2,882,043.22. Payment terms for Milestones 25 through 29 will follow the previous payment agreement for milestones between VITA and Supplier, unless otherwise updated at a future time.”

The foregoing is the complete and final expression of the agreement between Supplier and VITA to modify the Agreement and cannot be modified, except by a writing signed by a duly authorized representative of each of Supplier and VITA.
