**Exhibit B - Options List and Pricing****Instructions:**

Suppliers have provided pricing as a menu of services according to category. Options/Pricing includes all associated offerings and all line item prices/fees/costs necessary for the Authorized User to build a Statement of Work (SOW) for services.

A SOW, in a format similar to that provided for in Exhibit D attached to this Contract, is required for any orders placed by an Authorized User. SOWs, in accordance with Contract section 17.F "Ordering" and 17.G "Statement of Work", will be of a fixed price type, with payment tied to defined deliverables, unless VITA issues a written authorization for a time and materials type SOW. The SOW shall include (a) a detailed description of each product or service proposed, including any applicable components, at the Exhibit B line item fee level; (b) the quantity of each line item; (c) the total contract price; (d) any additional percentage discount offered; (e) an extended price; (f) any optional or alternate pricing; (g) any pricing assumptions; and (h) this Contract number. The fixed price SOWs may, with the written approval of VITA, contain a cost-reimbursable line item(s) for pre-approved travel expenses pursuant to the provisions of Contract section 17.1 "Reimbursement of Expenses". If a time and materials type SOW is authorized, Supplier Personnel shall maintain daily time records of hours and tasks performed that must be submitted or made available for inspection by the Authorized User upon 48 hours advance written notice.

Any change to an SOW must be described in a written change request, in the format provided in Exhibit E. Either Party to an SOW may issue a change request that will be subject to written approval of the other Party before it becomes part of this Contract. In no event will any SOW or any modification require the Supplier to provide any Products or Services that are beyond the scope of this Contract as such scope is defined in Exhibit A, which is attached to this Contract and incorporated by reference.

**Convenience Funding/Fees (Citizen/User-funded)** - In some instances, convenience fees are approved by the government to fund delivery of services. Convenience funding/fee arrangements are agreed to by the Authorized User and Supplier, defined in the SOW, collected directly from citizens during payment processing; and then are applied by the supplier to the total cost of an Authorized User's SOW, a line item of the SOW (such as monthly O&M), or to a specific transaction service.

Convenience-funded models (also described as a self-funded, transaction-funded, service-fee-funded or hybrid-funded model) are usually reliant on services that include a high-volume of citizen transactions but may alleviate the need for government-appropriated funding to fund part or all of the costs associated with an SOW. Under this Contract, convenience funding arrangements (paid through citizen convenience fees) must be defined in the SOW and describe the manner in which convenience fees will sunset once the fixed price of the SOW or applicable line item price is reached unless the fee is for a transaction based service (i.e. event registration fee, etc.)

**Service fee Model and Hybrid Model:** In instances where an agency does not have the full resources to fund a standard fixed rate SOW model and/or ongoing O&M for a solution, a service fee funding model or a hybrid of service and SOW models may be proposed if the customer has sufficient credit card transaction volumes to fund a SOW in a reasonable time-frame. If a SOW uses this model for funding, the service fee will cease once the SOW estimated amount is reached and or be reduced to cover ongoing O&M for a solution. We will utilize Elavon back-end administration portal to report all service fee transaction "sales" for the prior month, when utilizing citizen paid service fee model in whole or in part. Service fees will adhere to state and federal laws, and card providers rules and regulations.

IF an agency or public body chooses to fund any portion of SOWs or ongoing O&M, they can choose citizen paid option in row 2 above. Service fees will adhere to state, federal, and card providers rules and regulations. Service fee Model and Hybrid Model: In instances where an agency does not have the full resources to cover the typical agency/public body funded fixed price SOW and/or ongoing O&M costs, a service fee funding model or a hybrid of service fee and self funded SOW models may be offered if the customer has sufficient credit card transaction volumes to fund a SOW in a reasonable time-frame. If a SOW uses this model, the service fee will cease once the SOW estimated amount is funded. We will utilize this account and the Elavon back-end administration portal to report all service fee transactions and "sales" for the prior month. This service fees is collected above and beyond the card processing service fee. Agencies and public bodies wishing to utilize the service fee will go through the Sitevision-Elavon, agencies that wish to pay for processing fees and have no service fees paid by citizens may go choose either the COV Treasury-Elavon option or SiteVision-Elavon option.
