

MODIFICATION NO. 1
TO
CONTRACT NUMBER VA-190906-VIPN
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
Virginia Interactive

This Modification No. 1 (“**Modification**”) is an agreement between the Virginia Information Technologies Agency (“**VITA**”), pursuant to § 2.2-2012 of the *Code of Virginia* and on behalf of the Commonwealth of Virginia (“**Commonwealth**”), and Virginia Interactive (“**Supplier**”), to modify and amend Contract No. VA-190906-VIPN (“**Contract**”) in accordance with the terms and conditions of this Modification. This Modification and any attachments thereto is, upon execution by VITA and Supplier (each a “**Party**” and, collectively, the “**Parties**”), incorporated into and made an integral part of the Contract.

Capitalized terms used in this Modification have the meaning ascribed to them in the Contract unless otherwise defined in this Modification.

In consideration of the recitals set forth above, which are hereby restated and agreed to by the Parties, and for valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Parties, Supplier and VITA agree to amend the Contract as follows:

Referencing “VA-190906-VIPN EXHIBIT B Options Pricing”; revise and replace with “VA-190906-VIPN EXHIBIT B OPTIONS PRICING (Jan 2025)” (attached) to reflect the following changes:

- a) Revise all pricing to reflect an increase of three (3) percent (%) as defined by section 17.A “Fees and Charges” of the Contract.
- b) Add web remediation service options/pricing (Table 1B), which shall only be made available to customers not currently hosted or serviced under the Contract. Per section 17.G “Statement of Work” of the Contract, “A SOW, in the format provided for in Exhibit D attached to this Contract, is required for any orders placed by an Authorized User pursuant to this Contract.” This requirement remains applicable to work priced through Table 1A.

The changes set forth in this Modification are effective immediately.

The foregoing is the complete and final expression of the agreement between Supplier and VITA to modify the Contract and cannot be modified, except by writing signed by duly authorized representatives of both parties.

ALL OTHER TERMS AND CONDITIONS OF THE CONTRACT REMAIN UNCHANGED.

PERSONS SIGNING THIS MODIFICATION ARE AUTHORIZED REPRESENTATIVES OF EACH PARTY TO THE CONTRACT AND ACKNOWLEDGE THAT EACH OF THE SUPPLIER AND THE COMMONWEALTH AGREES TO BE BOUND BY THE TERMS AND CONDITIONS OF THE CONTRACT.
