Exhibit B - Options List and Pricing

Instructions:

Suppliers have provided pricing as a menu of services according to category. Options/Pricing includes all associated offerings and all line item prices/fees/costs necessary for the Authorized User to build a Statement of Work (SOW) for services.

A SOW, in a format similar to that provided for in Exhibit D attached to this Contract, is required for any orders placed by an Authorized User. SOWs, in accordance with Contract section 17.F "Ordering" and 17.G "Statement of Work", will be of a fixed price type, with payment tied to defined deliverables, unless VITA issues a written authorization for a time and materials type SOW. The SOW shall include (a) a detailed description of each product or service proposed, including any applicable components, at the Exhibit B line item fee level; (b) the quantity of each line item; (c) the total contract price; (d) any additional percentage discount offered; (e) an extended price; (f) any optional or alternate pricing; (g) any pricing assumptions; and (h) this Contract number. The fixed price SOWs may, with the written approval of VITA, contain a cost-reimbursable line item(s) for pre-approved travel expenses pursuant to the provisions of Contract section 17.I "Reimbursement of Expenses". If a time and materials type SOW is authorized, Supplier Personnel shall maintain daily time records of hours and tasks performed that must be submitted or made available for inspection by the Authorized User upon 48 hours advance written notice.

Any change to an SOW must be described in a written change request, in the format provided in Exhibit E. Either Party to an SOW may issue a change request that will be subject to written approval of the other Party before it becomes part of this Contract. In no event will any SOW or any modification require the Supplier to provide any Products or Services that are beyond the scope of this Contract as such scope is defined in Exhibit A, which is attached to this Contract and incorporated by reference.

SOWs and Change Orders must be transparent, with pricing components that visibly correlate with the Exhibit B Options/Pricing line item fee level. If hourly labor defines a price component, the labor category, rate and unit of measure must be listed and correlate with the Exhibit B Options/Pricing line item labor description and fee level.

Subscription and transaction-based services and fees must be defined and correlate with Exhibit B Options/Pricing line item description and fee level. Convenience funding arrangements, paid through citizen convenience fees, must be defined in the SOW and describe the manner in which convenience fees will sunset once the fixed price of the SOW or applicable line item price is reached.

Convenience Funding/Fees (Citizen/User-funded) - In some instances, convenience fees are approved by the government to fund delivery of services. Convenience funding/fee arrangements are agreed to by the Authorized User and Supplier, defined in the SOW, collected directly from citizens during payment processing; and then are applied by the supplier to the total cost of an Authorized User's SOW, a line item of the SOW (such as monthly O&M), or to a specific transaction service.

Convenience-funded models (also described as a self-funded, transaction-funded or hybrid-funded model) are usually reliant on services that include a high-volume of citizen transactions but may alleviate the need for government-appropriated funding to fund part or all of the costs associated with an SOW. Under this Contract, convenience funding arrangements (paid through citizen convenience fees) must be defined in the SOW and describe the manner in which convenience fees will sunset once the fixed price of the SOW or applicable line item price is reached unless the fee is for a transaction based service (i.e. event registration fee, etc.)

Exhibit B - Options/Pricing	The proposed labor rates in Table 1 are considered the maximum hourly rates for the first two (2) years of the contract. Rates may be discounted on a case-by-case basis through the Statement of Work process.
Exhibit B - Options/Pricing	The SaaS and Subscription fees included in Table 5 are quoted on an annual basis and are considered maximum fees for the first two (2) years of the contract. For certain SaaS and Subscription services, a transaction-fee model covers the fee for the service. Individual fees in Table 5 will be negotiated on a case-by-case basis through the SOW process. Depending upon the level of configuration, set-up and customization for each individual project, there may be a separate implementation fee outlined in the SOW for some SaaS or Subscription solution based on the labor categories in VI's pricing menu.
Exhibit B - Options/Pricing	VI offers private-cloud via our Class IV data center (Table 2) and public-cloud pricing offered by Microsoft Azure (Table 3) for future Statements of Work. All final project fees will be finalized during the SOW process, but will correlate with fees listed in Exhibit B Options/Pricing.

<p>Payment Processing</p>	<p>The Citizen-paid/Agency-absorbed fees described in Table 6 outline the per-transaction fees exclusively for payment processing for credit cards and ACH. The first option provides the proposed fee when the Commonwealth is the Merchant of Record and the Commonwealth is responsible for third-party fees to process transactions charged by credit card companies. The second option outlines the payment processing fees when VI is the Merchant of Record. The last item is the proposed fee to process ACH/eChecks.</p>
<p>SaaS and Subscription Services</p>	<p>In some cases, VI may provide complex transaction-based digital government services that have requirements beyond basic payment processing. For example, VI has proposed several SaaS solutions (Table 5) that may be funded by citizen-paid fees – Gov2Go digital government assistant, event registration, hunting and fishing licenses, park passes, and campground reservations – that have requirements that extend beyond payment processing and can be funded by citizen-paid fees. VI is confident that in the majority of future SOWs, the citizen paid convenience fee will be the fee listed in Exhibit B or less as negotiated in the SOW based on our experience in setting fees for similar citizen-facing services. For some solutions, there may be special requirements or complex specifications that require a higher fee. In those instances, VI will use the SOW process to reach agreement on final citizen paid convenience fees. Convenience funding arrangements, paid through citizen convenience fees, will be defined in the SOW and describe the manner in which convenience fees will sunset once the fixed price of the SOW or applicable line item price is reached.</p>
<p>SaaS and Subscription Services</p>	<p>VI priced several SaaS solutions – Gov2Go digital government assistant, AppEngine, event registration, hunting and fishing licenses, park passes, and campground reservations – to be funded using citizen-paid fees. Some agencies may want to fund these services via monthly or annual subscription fees. At the option of the Authorized User, VI will use the SOW process to reach agreement on final SaaS fees.</p>
<p>SaaS and Subscription Services</p>	<p>As described in Exhibit B Table 5, VI offers several subscription-based premium services for authorized business users who conduct business across multiple agencies. The Annual Fee, which is charged to the business user, covers administrative tasks to manage their accounts and ensure that they have signed and maintained proper documentation to authorize access to government records. In some cases, business users are charged a monthly transaction fee on total transactions, which would be charged in accordance with the listed citizen-paid fee. In other cases, the business user may be eligible to download certain government records in accordance with commonwealth law. Download fees are charged to the business user to download eligible databases. For example, a marine repair business may want to download a database of registered boaters.</p>

Pricing and Funding Models

VI has proposed a variety of flexible funding models to address all of the business model needs for an enterprise digital government program across the commonwealth for all public bodies as defined in the Contract. Based on our vast experience funding similar enterprise digital government programs, the commonwealth will likely use all of the cost models proposed for individual SOWs or a combination of these proposed models (hybrid funding) to fund enterprise services. In some cases, for example, citizen- paid convenience funding/fees may cover ongoing support, hosting and maintenance costs. Convenience funding arrangements, paid through citizen convenience fees, will be defined in the SOW and describe the manner in which convenience fees will sunset once the fixed price of the SOW or applicable line item price is reached.
