

**MODIFICATION #2
TO
CONTRACT NUMBER VA-191201-ABEL
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
BREEZELINE LLC**

This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as “State” or “Commonwealth” or “VITA” (Virginia Information Technologies Agency), and Breezeline, LLC hereinafter referred to as “Contractor” or “Supplier”, relating to the modification of Contract VA-191201-ABEL as amended. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-ABEL..

1. The Parties agree to replace Exhibit A of the Contract with the new attached **Exhibit A (Pricing)**:
2. All Data circuits will be provided with electronics providing IP access with an Industry Standard Interface for Customer Provided Equipment. Such equipment/modem/router shall not provide WiFi. The customer shall provide their own WiFi Access Point, if required.
3. Any Managed Router or other programmable interface shall be provided solely for the convenience and use of the Supplier. Customer shall not have access to these devices for configuration purposes.
4. Unless otherwise specified Fiber speeds are symmetrical.
5. Pricing indicated in this Modification shall apply to all New and Existing customer as of the effective date of this Modification.
6. The Parties agree to replace the existing **Exhibit E** with the attached Exhibit E entitled **“EXHIBIT E – AGENCIES AND INDIVIDUALS AUTHORIZED TO ORDER SERVICES”**.

The foregoing is the complete and final expression of the parties' agreement to modify Contract VA-191201-ABEL and cannot be modified, except by a writing signed by duly authorized representatives of both parties.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.

PERSONS SIGNING THIS CONTRACT ARE AUTHORIZED REPRESENTATIVES OF EACH PARTY TO THIS CONTRACT AND ACKNOWLEDGE THAT EACH PARTY AGREES TO BE BOUND BY THE TERMS AND CONDITIONS OF THE CONTRACT.

EXHIBIT E

AGENCIES AND INDIVIDUALS AUTHORIZED TO ORDER SERVICES

The following Individuals or entities are authorized by VITA to order services under this contract:

- The Virginia Community Colleges Systems Offices

- Calero.com Employees authorized by VITA to issue orders

The Supplier shall not accept orders for services from organizations or individuals other than those listed above. The Virginia Community Colleges may use the Commonwealth's eVA ordering portal and may be “Direct Billed” for their services. All other orders must come directly from VITA on a Telecommunications Work Order (Exhibit C). Any orders submitted through eVA or directly from a customer in the form of a Purchase Order, except as above, must be returned, and the ordering officer informed of the correct ordering procedures outlined in this contract. In the event the Supplier acts on an invalid order, they shall assist the customer to correct the order within 30 days of discovery of the mistake.

Any Authorized User who participates in the E-Rate Program may apply to VITA to be “Direct Billed” by the Supplier. Orders must however be submitted through the VITA Ordering Portal in accordance with VITA’s ordering procedures for Telecommunications services. The Supplier will be notified of any “Direct Bill” approvals and orders for the services will clearly indicate the “Bill To” address.

The Supplier is responsible for ensuring all orders are processed in accordance the established procedures. Any orders place outside of the prescribed ordering procedures are not considered contract orders and are not eligible for contract pricing or other discounts.
