

**MODIFICATION #2  
TO  
CONTRACT NUMBER VA-191201-BCI  
BETWEEN THE  
COMMONWEALTH OF VIRGINIA  
AND  
BRIGHTSTAR COMMUNICATIONS INC**

This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as “State” or “Commonwealth” or “VITA” (Virginia Information Technologies Agency), and Brightstar. Communications Inc, hereinafter referred to as “Contractor,” relating to the modification of Contract VA-191201-BCI as amended. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-BCI.

1. The Parties agree to **ADD** the following **New** service in Exhibit A as follows:

- MRC denotes Monthly Recurring Charge.
- Installation includes providing, installing, configuration and testing of all required equipment necessary for two-way communications, including Internet access, with minimum connection speed as indicated in the table above.
- Installed equipment shall have an Ethernet jack for Customer Provided Equipment (CPE) interface.
- Installed equipment shall remain the property of the Supplier, who shall be responsible for keeping such equipment in good operating condition.
- Customer will not have access to the hardware administration function of supplied equipment.
- Static IP Addresses are available for \$15 each, supports /30 to /27 Blocks.
- For security reasons, installation at State Executive Branch Agencies will not include WiFi service

The foregoing is the complete and final expression of the parties' agreement to modify Contract VA-191201-BCI and cannot be modified, except by a writing signed by duly authorized representatives of both parties.
