

**MODIFICATION #6
TO CONTRACT NUMBER VA-191201-BCI
BETWEEN THE COMMONWEALTH OF VIRGINIA
AND BRIGHTSTAR COMMUNICATIONS INC**

This MODIFICATION #6 (the “**Sixth Modification**”) is an agreement between the Virginia Information Technologies Agency (“**VITA**”), pursuant to § 2.2-2012 of the *Code of Virginia* and on behalf of the Commonwealth of Virginia (“**Commonwealth**” or “**State**”), and Brightstar Communications Inc, (“**Supplier**”). This Modification is hereby incorporated into and made an integral part of Contract VA-191201-BCI, as amended, between VITA and the Supplier (the “**Supplier**”).

This Modification documents both parties’ agreement to amend the Contract as follows:

- All Starlink Fixed Site Service Plans require a one-year service term commitment. Month-to month terms apply after one-year term for the remainder of service. Services continue until cancelled.
- Managed Installation for Starlink Fixed Site Service Plans is required, and billed at the end of the month service is installed.
- Starlink Fixed Site Managed Installation includes all travel, transportation costs for any/all materials, required Starlink hardware, installation of the normal, standard software, equipment and testing to confirm service is operational.
- Customer Provided Equipment (CPE) will connect to the provided Starlink service via an Industry Standard physical interface (RJ-45 Ethernet jack or similar). No customer access is allowed to any supplied hardware or software which would allow configuration or feature changes. All supplied hardware shall remain the property of Supplier.
- *Priority Traffic Allocation is monitored on a monthly basis. If Data Usage exceeds Priority Data Allocation on Service Plan within any given month, data throughput will be reduced to 1 Mbps download speed and .5 Mbps upload speed for the remainder of month.
- No overage charges will apply on Starlink Fixed Site or Starlink Mobile Service Plans.
- 50 GB Top Off Priority Traffic Allocation may be added to any Starlink Fixed Site Service Plan for \$75.00 per month added to Service Plan Monthly Service Cost for the remainder of service.

- 100 GB Top Off Priority Traffic Allocation may be added to any Starlink Fixed Site Service Plan for \$135.00 per month added to Service Plan Monthly Service Cost for the remainder of service.
- Starlink Fixed Site Service Plans may be upgraded to a Service Plan with higher Priority Traffic Allocation. Upgraded Service Plan Monthly Service Cost will apply for the remainder of service.
- Failover Wireless Internet Service is included on all Starlink Fixed Site Service Plans, with 5 GB monthly allocation per location.
- ** Optional Unlimited Failover Wireless Internet Service is available on Starlink Fixed Site Service Plans, for an additional \$200.00 per month for locations that qualify.
- One (1) Managed Static IP Address per location is provided
- Customer Wi-Fi access will not be included.
- Monthly Service Cost is inclusive of all Taxes and Fees.

- All Starlink Mobile Service Plans require a one-year service term commitment. Month-to month terms apply after one-year term for the remainder of service.
- Managed Installation is not included on Starlink Mobile Plans. References for 3rd Party Mobile Plan installers will be provided by the Supplier upon request.
- Starlink Mobile Plan antenna options have a one-time cost of \$2,500.00 for Starlink Flat High-Performance Kit, or a one-time cost of \$700.00 for Starlink Enterprise Dish Kit plus a \$150.00 shipping fee for each Starlink antenna.
- Unlimited Failover Wireless Option is not supported for Starlink Mobile Plans.
- Automobile applications are not supported for Starlink Mobile Plans.
- *Priority Traffic Allocation is monitored on a monthly basis. If Data Usage exceeds Priority Data Allocation on Service Plan within any given month, data throughput will be reduced to 1 Mbps download speed and .5 Mbps upload speed for the remainder of month.
- No overage charges will apply on Starlink Fixed Site or Starlink Mobile Service Plans.
- 50 GB Top Off Priority Traffic Allocation may be added to any Starlink Fixed Site Service Plan for \$75.00 per month added to Service Plan Monthly Service Cost for the remainder of service.
- One (1) Managed Static IP Address per location is provided
- Customer Wi-Fi access will not be included.
- Monthly Service Cost is inclusive of all Taxes and Fees.

The foregoing is the complete and final expression of the parties' agreement to modify Contract VA-191201-BCI and cannot be modified, except by a writing signed by duly authorized representatives of both parties.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
