

**MODIFICATION #2
TO
CONTRACT NUMBER VA-191201-CCBC
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
COMCAST BUSINESS COMMUNICATIONS, LLC**

This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as “State” or “Commonwealth” or “VITA” (Virginia Information Technologies Agency), and Comcast Business Communications LLC, hereinafter referred to as “Contractor,” relating to the modification of Contract VA-191201-CCBC as amended. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-CCBC.

1. Exhibit A – Pricing

The Parties agree to replace the Television Service offerings with the following:

Description	Installation Fee	Monthly Service Fee (No Term)	Usage Charge
Cable TV - Variety	\$99.95	\$44.95	NA
Cable TV – Standard	\$99.95	\$74.95	NA
Equipment Fee (per Outlet)		\$9.95	NA
mDTA	\$750.00	\$450	NA

- Installation fee is per Location for initial installation. Additional orders for the same location that require onsite installation will incur a \$69.95 installation fee.
- All TV Service include all included Channels in HD (when available in that resolution)
- Content of the Variety and Standard TV packages subject to change.
- The equipment fee is charged per outlet, jack or termination, including the first one.
- mDTA designed for a building with a large number of TV devices and eliminates the need for individual interface equipment. mDTA monthly charges provide for up to 100 terminations of Standard Definition TV. HD Television is not available with a mDTA. Customer must provide internal cable from the customer provided devices to the Comcast demarc location and is responsible for all internal wiring when using a mDTA.
- Initial mDTA order should identify the total number of “anticipated” connections, up to 100.
- Customers selecting an mDTA installation must order at least one Standard TV package and one converter box in addition to the mDTA, making the total Monthly Recurring Charge (MRC) \$534.90.

2. Billing

All Billing for the above services shall be in accordance with the Contract Terms and Conditions.

The foregoing is the complete and final expression of the parties' agreement to modify Contract VA-191201-CCBC and cannot be modified, except by a writing signed by duly authorized representatives of both parties.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.


