

**MODIFICATION #3
TO
CONTRACT NUMBER VA-191201-CCBC
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
COMCAST BUSINESS COMMUNICATIONS, LLC**

This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as “State” or “Commonwealth” or “VITA” (Virginia Information Technologies Agency), and Comcast Business Communications LLC, hereinafter referred to as “Contractor,” relating to the modification of Contract VA-191201-CCBC as amended. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-CCBC.

1. The Parties agree to extend the Term of the contract through June 30, 2022.

2. ADD to Section 2 - DEFINITIONS

II. **Long Distance Toll (interLATA) Service** includes all calls outside the local exchange and toll service areas, calls that originate in one LATA and terminate in another, and international calls.

3. The Parties agree to the addition of the following SIP Trunk Service as detailed below.

SIP Trunks	\$500 /site	\$0.00	\$13.00 ea.	200/ per CCS	\$0.03 / per min.

- SIP Trunks are available to all entities eligible to purchase from this contract.
- Executive Branch agencies must acquire a formal VITA “Exception” to acquire these and other Broadband services. Such an Exception must be obtained prior to ordering this service.
- All orders (including DSP Orders) for this service will be placed through the VITA Simple Work Order process, as outlined in the Contract.
- CCS is defined as “Concurrent Call Sessions”, “Call Path” or “Trunks”
- This service is a “month to Month” service and may be cancelled with 30 days notice.
- Dedicated Bandwidth. The Bandwidth for SIP Trunks shall not reduce the available bandwidth for the Customer Location’s existing Tiered connections for Internet Services.
- The Monthly Recurring Charges (MRC) will vary, based on the number of active call paths (CCS) and any additional Long Distance minutes, over the included allotment.
- Unlimited Local and intra-LATA calls are included
- 200 minutes of Long Distance is included with each SIP Trunk ordered and aggregated for billing purposes by customer.
- The quoted prices are inclusive of all taxes and fees.

The foregoing is the complete and final expression of the parties' agreement to modify Contract VA-191201-CCBC and cannot be modified, except by a writing signed by duly authorized representatives of both parties.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.

PERSONS SIGNING THIS CONTRACT ARE AUTHORIZED REPRESENTATIVES OF EACH PARTY TO THIS CONTRACT AND ACKNOWLEDGE THAT EACH PARTY AGREES TO BE BOUND BY THE TERMS AND CONDITIONS OF THE CONTRACT.
