

**MODIFICATION #5  
TO  
CONTRACT NUMBER VA-191201-CCBC  
BETWEEN THE  
COMMONWEALTH OF VIRGINIA  
AND  
COMCAST BUSINESS COMMUNICATIONS, LLC**

This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as “State” or “Commonwealth” or “VITA” (Virginia Information Technologies Agency), and Comcast Business Communications LLC, hereinafter referred to as “Contractor,” relating to the modification of Contract VA-191201-CCBC as amended. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-CCBC.

**1. Exhibit A – Pricing**

The Parties agree to **Add** the following Television Service offerings to Exhibit A:

**HD uDTA TV Service**

- HD uDTA service is provided for non-office and non-common area applications. Standard service should be ordered for office and common areas.
- Installation fee is per Location for initial installation.
- Cabling is the responsibility of the customer agency.
- All TV Service include all included Channels in HD (when available in that resolution)
- The HD uDTA service includes a Standard Programming Package. The contents of the package will vary by geographic location.
- The equipment fee is charged per outlet, jack or termination, including the first one.
- Wall-mounted HD uDTA’s require in-wall gang box(s) to be in place.
- Customers should consult and coordinate with Comcast prior to ordering HD uDTA service.

- QAM to QAM (Q2Q) distribution provides secure HD programming to customers without the need for set-top boxes for each display. Service requires PRO:Idiom TV sets to decrypt the encrypted signals
- QAM to QAM service is designed for facilities with a large number of Television outlets. A minimum of 60 must be on the initial order, unless agreed to by Comcast.
- QAM to QAM requires standard Coaxial cable wiring to each outlet. Cabling is the responsibility of the customer agency.
- A standard programming package is provided. The channel lineup may vary by geographic area

- QAM to IP service is designed for facilities with a large number of Television sets. A minimum of 90 must be on the initial order, unless agreed to by Comcast.
- QAM to IP requires Ethernet cabling to each TV location. Cabling is the responsibility of the customer agency.
- A standard programming package is provided. The channel lineup may vary by geographic area
