

**MODIFICATION #6
TO
CONTRACT NUMBER VA-191201-CCBC
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
COMCAST BUSINESS COMMUNICATIONS, LLC**

This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as “State” or “Commonwealth” or “VITA” (Virginia Information Technologies Agency), and Comcast Business Communications LLC, hereinafter referred to as “Contractor,” relating to the modification of Contract VA-191201-CCBC as amended.
