

**MODIFICATION #2  
TO  
CONTRACT NUMBER VA-191201-CXCM  
BETWEEN THE  
COMMONWEALTH OF VIRGINIA

COX VIRGINIA TELCOM LLC**

This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as “State” or “Commonwealth” or “VITA” (Virginia Information Technologies Agency), and Cox Virginia Telcom LLC, doing business as Cox Business, Cox Communications Hampton Roads LLC and CoxCom LLC, hereinafter referred to as “Contractor” or “Supplier”, relating to the modification of Contract VA-191201-CXCM, as amended. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-CXCM (the “Contract”).


