

**MODIFICATION #5  
TO  
CONTRACT NUMBER VA-191201-CXCM  
BETWEEN THE  
COMMONWEALTH OF VIRGINIA  
AND  
COX VIRGINIA TELCOM, LLC.**

This MODIFICATION #5 (the “**Fifth Modification**”) is an Agreement between the Virginia Information Technologies Agency (“**VITA**”), pursuant to § 2.2-2012 of the *Code of Virginia* and on the behalf of the Commonwealth of Virginia (“**Commonwealth**” or “**State**”) and Cox Virginia Telcom, LLC doing business as Cox Business, Cox Communications Hampton Roads, LLC and CoxCom, LLC, hereinafter referred to as “**Contractor**” or “**Supplier**”. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-CXCM (as amended, the “Contract”), between VITA and the Supplier.

1. The Parties agree to the following changes to Exhibit A (Pricing)

**ADD** the following Non-Tiered Voice Service:

- Virtual Number Service provides a “virtual” phone number that can be routed to any valid telephone number selected by the customer.
- Service includes the ability to route calls based on time of day and provides other features which may be standard to the Suppliers offering.



## **EXHIBIT E**

### **AGENCIES AND INDIVIDUALS AUTHORIZED TO ORDER SERVICES**

The following Individuals or entities are authorized by VITA to order services under this contact:

The Supplier shall not accept orders for services under the Contract from organizations or individuals other than those listed above. The Supreme Court and Virginia Community Colleges may use the Commonwealth's eVA ordering portal and may be “Direct Billed” for the services such entities purchase under the Contract. All other orders must come directly from VITA. Any orders submitted through eVA, or on a Agency Purchase Order, except as above, must be returned and the ordering officer informed of the correct ordering procedures outlined in this Contract. In the event the Supplier acts on an invalid order, they shall assist the customer to correct the order within 30 days of discovery of the mistake.

### **DIRECT BILL CUSTOMERS**

Any Authorized User who participates in the eRate Program may apply to VITA to be “Direct Billed” by the Supplier. Orders must still come from VITA and must be submitted through the VITA Ordering Portal in accordance with VITA’s ordering procedures for Telecommunications services. The Supplier will be notified of any “Direct Bill” approvals and orders for the services will clearly indicate the “Bill To” address.

All services supplied to any Regular or Direct Bill (or eRate) customer must be at the Contract pricing. (see Section 18, sub-Section S entitled “Most Favored Customer”)

The Supplier is responsible for ensuring all orders are processed in accordance the established procedures.
