

**MODIFICATION #8
TO
CONTRACT NUMBER VA-191201-CXCM
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
COX VIRGINIA TELCOM, LLC.**

This MODIFICATION #8 (the “**Eighth Modification**”) is an Agreement between the Virginia Information Technologies Agency (“**VITA**”), pursuant to § 2.2-2012 of the *Code of Virginia* and on the behalf of the Commonwealth of Virginia (“**Commonwealth**” or “**State**”) and Cox Virginia Telcom, LLC doing business as Cox Business, Cox Communications Hampton Roads, LLC and CoxCom, LLC, hereinafter referred to as “**Contractor**” or “**Supplier**”. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-CXCM, as amended, between VITA and the Supplier.

- Any provided hardware (Modem, Router, Switch, etc.) shall not provide a WiFi Access Point.
- The operating environment (OS, Firmware, software, etc.) for any provided hardware (Modem, Router, etc.) must not be accessible to the VITA Customer, but access may be provided to VITA or its Network Managed Service Provider (MSP), if requested in writing by VITA.


