Dear VITA Broadband Contract Supplier:

Pursuant to Section 3.G "Transition of Services" of the subject Contract, VITA is hereby exercising its right to request and institute a Transition Period beginning on July 1, 2025, to provide for Eligible E-Rate Entities to continue to receive Services that are available pursuant to the Contract on a month-to-month basis, at each Eligible E-Rate Entity's sole discretion, through at least E-Rate Funding Year 2025, which ends on June 30, 2026. While this notice specifically invokes the Transition of Services clause for the limited purpose of providing E-Rate Eligible Services, including ineligible services incidental to such E-Rate Eligible Services, VITA reserves the right to expand the purpose and scope of such Transition of Services, and any related Transition Period, to the full extent provided in the Contract, including on behalf of VITA, any Authorized Users, and their Subscribers.
