

**MODIFICATION #2  
TO  
CONTRACT NUMBER VA-191201-IPA  
BETWEEN THE  
COMMONWEALTH OF VIRGINIA  
AND  
IP ACCESS INTERNATIONAL INC**

This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as "State" or "Commonwealth" or "VITA" (Virginia Information Technologies Agency), and IP Access International Inc. hereinafter referred to as "Contractor," relating to the modification of Contract VA-191201-IPA as amended. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-IPA.

1. The Parties agree to **ADD** the following Services to Exhibit A (Pricing)

- Pricing is for service only and excludes the cost of necessary STARLINK hardware. Hardware must be purchased separately, either from the Supplier or other hardware providers. Installation is not included.
- The Flat High-Performance Antenna is the required antenna by STARLINK for Priority service customers.
- All Service Plans come with a Static Public IP and are not network managed.
- Fixed Data plans may not be used on Mobile Platforms.
- Service is available in all geographic areas of Virginia.
- The Monthly Allotment for all Plans is for STARLINK Priority Data Service.
- Priority and Mobile Priority data is given network precedence over Standard and Mobile data, meaning users will experience more throughput and faster speeds at times of network congestion. See STARLINK's Web Site for Specifications and details on the expected performance per Service Plan

- Pricing is for service only and excludes the cost of necessary OneWeb hardware. Hardware must be purchased separately, either from the Supplier or other hardware providers. Installation is not included with the service. Installation and Annual Support is optional, although one year of Annual Hardware Support is included with the Kymeta U8 Antenna Kit.

The service includes OneWeb Satellite Service and three terrestrial Wireless Services (typically AT&T/FirstNet, T-Mobile and Verizon Wireless). User data seamlessly utilizes all available wireless connections to access the internet. FirstNet provided if the customer qualifies.
- Service and Equipment Bundles suitable for Fixed or Mobile deployment.
- This plan is good for one-year or until the data allotment is consumed.
- All pricing is USD and excludes any applicable Taxes and shipping (if required)
- Service is available in all geographic areas of Virginia.
- The "Annual Data" allotment is for any combination of Satellite and Terrestrial Wireless activity.
- Pricing excludes the cost of necessary hardware Bundle, which must be purchased separately from the service. SuperGIG requires one of the two hardware bundles, along with Installation. Contact the Supplier prior to ordering to identify which hardware bundles is best suited for the site. ### **AGENCIES AND INDIVIDUALS AUTHORIZED TO ORDER SERVICES**

The Supplier shall not accept orders for services from organizations or individuals other than those listed above. All other orders must come directly from VITA on a Telecommunications Work Order (Exhibit C or its successor). Any orders submitted through eVA or directly from a customer in the form of Purchase Order, except as above, must be returned, and the ordering officer informed of the correct ordering procedures outlined in this contract. In the event the Supplier acts on an invalid order, they shall assist the customer to correct the order within 30 days of discovery of the mistake.

Any Authorized User who participates in the eRate Program may apply to VITA to be "Direct Billed" by the Supplier. Orders must however be submitted through the VITA Ordering Portal in accordance with VITA's ordering procedures for Telecommunications services. The Supplier will be notified of any "Direct Bill" approvals and orders for the services will clearly indicate the "Bill To" address.

The Supplier is responsible for ensuring all orders are processed in accordance the established procedures.
