

**MODIFICATION #4
TO
CONTRACT NUMBER VA-191201-IPA
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
IP ACCESS INTERNATIONAL LLC**

This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as “State” or “Commonwealth” or “VITA” (Virginia Information Technologies Agency), and IP Access International LLC, hereinafter referred to as “Contractor,” relating to the modification of Contract VA-191201-IPA as amended. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-IPA.

1. The Parties agree to **Replace** the following Starlink Services to Exhibit A (Pricing)

Low Earth Orbit Satellite (STARLINK Local Priority Service)

- All plans require a one-year service commitment. The annual cost is billed during the first month of use, or month following the order.
- All plans are suitable for both Fixed locations and Mobile installations.
- Pricing is for service only and excludes the cost of necessary STARLINK hardware. Hardware must be purchased separately, either from the supplier or other hardware providers. Installation is not included.
- Subscribers can opt-in to automatically top-up data in incremental blocks of 50GB. These top-ups will automatically trigger once data is fully consumed (either monthly plan allowance or prior 50GB top-up). The billing for additional blocks will occur post top-up(s). All data, including top-ups reset to the purchased monthly data allotment at the plan’s monthly service cycle. Subscribers must make their intention to opt-in known at the time the initial annual services are order.
- All service plans come with a public IP and are not network managed.
- Service is available in all geographic areas of Virginia.
- 350Mbps is the rated “peak” speed, actual average throughput speeds will be less. See the Starlink website for typical or expected performance information.
- The monthly allotment for all plans is for STARLINK priority data service.
- Priority data is given network precedence, meaning users will experience more throughput and faster speeds at times of network congestion. See STARLINK’s web site for specifications and details on the expected performance per Service Plan

- A Site Survey is required, and upon completion of the site survey, the customer will receive a formal quote for the installation (typically 7 -10 business days). The customer is under no obligation, beyond the cost of the site survey to continue with the installation should the quotation be deemed unacceptable.
- The customer must agree and provide written accept the cost of installation prior to the installation being scheduled.

- If the quote for the installation is found unacceptable, the site survey will be billed directly to the customer at that time.
- If the customer proceeds with the installation, the costs for both the site survey and installation will be billed directly to the customer upon completion and signoff by the customer on the installation.

The foregoing is the complete and final expression of the parties' agreement to modify Contract VA-191201-IPA and cannot be modified, except by a writing signed by duly authorized representatives of both parties.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
