

**MODIFICATION #1
TO

This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as "State" or "Commonwealth" or "VITA" (Virginia Information Technologies Agency), and Lumos Networks LLC, hereinafter referred to as "Contractor," relating to the modification of Contract VA-191201-LN as amended. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-LN.



In the event the Supplier acts on an invalid order, they shall assist the customer to correct the order within 30 days of discovery of the mistake.

DIRECT BILL CUSTOMERS

Any Authorized User who participates in the eRate Program may apply to VITA to be "Direct Billed" by the Supplier. Orders will still come from VITA and must be submitted through the VITA Ordering Portal in accordance with VITA's ordering procedures for Telecommunications services. The Supplier will be notified of any "Direct Bill" approvals and orders for the services will clearly indicate the "Bill To" address.

All services supplied to any Direct Bill (or eRate) customer must be at the Contract pricing. (see Section 18, sub-Section S entitled "Most Favored Customer")

The Supplier is responsible for ensuring all orders are processed in accordance the established procedures.
