

**MODIFICATION #2
TO
CONTRACT NUMBER VA-191201-LN
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
LUMOS NETWORKS LLC**

This MODIFICATION is an Agreement between the Commonwealth of Virginia, hereinafter referred to as “State” or “Commonwealth” or “VITA” (Virginia Information Technologies Agency), and Lumos Networks LLC, hereinafter referred to as “Contractor,” relating to the modification of Contract VA-191201-LN as amended. This Modification is hereby incorporated into and made an integral part of Contract VA-191201-LN.

1. All Data circuits acquired under this Contract will be provided with electronics providing IP or Digital access with an Industry Standard Interface to Customer Provided Equipment. Such equipment/modem/router shall not provide WiFi. The customer must provide their own WiFi Access Point if required.
2. The Parties agree to the addition of the following service to Exhibit A (Pricing).

- **IP Centrex/Hosted Voice Service** is available only to Higher Education and non-state entities eligible to purchase under this contract.
- “Subscriber(s)” is defined as a VITA Customer Agency to which the “IP Centrex/Hosted Voice Service” is delivered. VITA remains the “Customer of Record” for all installations for purposes of Customer Proprietary Network Information (CPNI).
- All orders for service will be entered into VITA’s Telecommunications Expense (Management) and Billing Solution (TEBS). Direct end-user ordering and billing is not provided.
- Supplier shall provide one (1) consolidated bill (invoice) for Voice Services each month. Individual locations may have their own Account or Sub-Account; however, there must be a “Master” invoice document or spreadsheet that all such separate account numbers “roll up” to.
- Contractor shall provide an electronic data file along with any monthly invoice containing sufficient information to reconcile the invoice and provide Call Detail records to the Subscriber.
- Any installation fees include normal installation and provisioning of initial and additional phone sets. Any construction or in-plant wiring is the responsibility of the Subscriber.
- Subscribers must provide an Internet circuit with bandwidth sufficient to support the number of seats. Supplier shall assist the Customer in the calculation of required bandwidth at no charge as part of pre-sales activity.
- Each seat includes unlimited Local and Domestic Long Distance, DIDs and E911. There are no “usage charges”.
- Multiple seat types may be selected at location(s) to accommodate end user specific requirements.
- Voice Mail is included with all seats.
- A standard desk set with ten (10) line appearances is provided. Supplier will provide VITA with the manufacturer and model of desk sets which are currently provided and update such list as it changes. VITA reserves the right to reject any equipment it deems of low quality.
- Basic, operational training is provided at the time of initial installation at no cost. Supplier will provide links to web-based training videos on basic equipment or call operations at no cost. The Subscriber may contract with the Supplier for additional on-site training which will be billed directly to the Subscriber agency.

- Supplier will provide 24/7 telephonic “Help Desk” assistance for non-working or “break-fix” situations. Replacement of defective desk sets will be by the quickest available means, but no worse than second day package delivery. If an outage requires the dispatch of a technician and is reported by noon, the response should be “same day”, otherwise before noon of the next day unless the Subscriber agrees to other arrangements in writing. Should the Subscriber be located in a location that is difficult to serve, the Supplier may store spare equipment at the site, with the Subscriber’s permission, without additional customer charges.
- Equipment remains the property of the Supplier and is supplied as part of the service. The supplier is responsible for timely replacement or repair of all equipment.
- The Supplier shall maintain Call Detail records for a minimum of 90 days and shall make such records available to VITA on demand.
- The provided Managed POE switch is for Supplier management. There is no Customer access.
- The only other charge that applies is FUSF, at the current approved rate.

The foregoing is the complete and final expression of the parties' agreement to modify Contract VA-191201-LN and cannot be modified, except by a writing signed by duly authorized representatives of both parties.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.

PERSONS SIGNING THIS CONTRACT ARE AUTHORIZED REPRESENTATIVES OF EACH PARTY TO THIS CONTRACT AND ACKNOWLEDGE THAT EACH PARTY AGREES TO BE BOUND BY THE TERMS AND CONDITIONS OF THE CONTRACT.
