- The operating environment (OS, Firmware, software, etc.) for any provided hardware (Modem, Router, etc.) must not be accessible to the VITA Customer in a manner that allows any configuration changes, but access may be provided to VITA or its Network Managed Service Provider (MSP), if specifically requested in writing by VITA.

  - Any provided hardware (Modem, Router, Switch, etc.) provided by the Supplier shall not provide a WiFi Access Point.
  - A Static IP is available for \$15 at time of order. Static IP addresses are limited to one (1) per Fiber circuit. Static IP added after the initial order subject to \$75 setup charge.
  - The operating environment (OS, Firmware, software, etc.) for any provided hardware (Modem, Router, etc.) must not be accessible to the VITA Customer in a manner that allows any configuration changes, but access may be provided to VITA or its Network Managed Service Provider (MSP), if specifically requested in writing by VITA.
2. Existing customers who have Cable Modem or Fiber to the Premise Service in Tiers 1-4 will remain with their current service and pricing until they desire to change their service. Pricing for all other customers, for services covered by this Modification #3, shall be adjusted to the new pricing effective with the billing cycle following execution of this Modification #3.

The foregoing is the complete and final expression of the parties' agreement to modify Contract VA-191201-SHEN and cannot be modified, except by a writing signed by duly authorized representatives of both parties.
