CONTRACT MODIFICATION NO. 5

PREAMBLE AND RECITATIONS

WHEREAS, the Virginia Information Technologies Agency (“**VITA**”), an agency of the Commonwealth of Virginia (“**Commonwealth**”) pursuant to § 2.2-2012 of the *Code of Virginia*, and Computer Aid, Inc. (“**Supplier**” or “**Contractor**”), a corporation headquartered at 1390 Ridgeview Drive, Allentown, PA 18104, entered into Commonwealth Contract No. VA-210625-CAI, effective as of June 25, 2021, (the “**Contract**”); and

WHEREAS, the Initial Term of the Contract authorized a five (5)-year term ending on June 25, 2026; and

WHEREAS, the Contract authorizes VITA, in its sole discretion, to renew the Contract for up to five (5) additional one (1)-year renewal periods; and

WHEREAS, VITA intends to exercise its option to renew the Contract for one (1) additional five (5)-year Renewal Term ending on June 25, 2031; and

WHEREAS, the Contract has been substantially modified through Modification Nos. 1, 2, 3, and 4; and

WHEREAS, the Parties desire to consolidate, amend, and restate the Contract and Modification Nos. 1, 2, 3, and 4 to better achieve the goals and objectives of the IT Contingent Labor Program; and

WHEREAS, the Parties have negotiated and agreed to this Contract Modification No. 5 to renew the Contract for one (1) additional five (5)-year Renewal Term ending on June 25, 2031; and

WHEREAS, as consideration for the five (5)-year Renewal Term of the Contract, the Parties have negotiated and agreed to a consolidated, amended, and restated Contract which is attached to this Modification No. 5; and

WHEREAS, Exhibit B Pricing, attached to the original Contract and incorporated by reference, is deleted in its entirety and replaced with Exhibit B Pricing attached to this Modification No. 5 and incorporated by reference; and

WHEREAS, Exhibit F Key Personnel, attached to the original Contract and incorporated by reference, is deleted in its entirety and replaced with Exhibit F Key Personnel attached to this Modification No. 5 and incorporated by reference;

NOW, THEREFORE, BE IT RESOLVED THAT:

Commonwealth Contract No. VA-210625-CAI, effective as of June 25, 2021, is renewed for one (1) additional five (5)-year Renewal Term ending on June 25, 2031; and

BE IT FURTHER RESOLVED THAT:

This Modification No. 5 is effective as of June 26, 2026.
