

**MODIFICATION NO. 02  
TO  
CONTRACT NUMBER VA-210625-DALY  
BETWEEN THE  
COMMONWEALTH OF VIRGINIA  
AND  
Daly Computers, Inc.**

This Modification No. 02 ("**Modification**") is an agreement between the Virginia Information Technologies Agency ("**VITA**"), pursuant to § 2.2-2012 of the *Code of Virginia* and on behalf of the Commonwealth of Virginia ("**Commonwealth**") and Daly Computer, Inc ("**Supplier**"), to modify and amend Contract No. VA-210625-DALY ("**Contract**") in accordance with the terms and conditions of this Modification. This Modification and any attachments thereto is, upon execution by VITA and Supplier (each a "**Party**" and, collectively, the "**Parties**"), incorporated into and made an integral part of the Contract.

Capitalized terms used in this Modification have the meaning ascribed to them in the Contract unless otherwise defined in this Modification.

In consideration of the recitals set forth above, which are hereby restated and agreed to by the Parties, and for valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Parties, Supplier and VITA agree to amend the Contract as follows:

1. **Incorporation of New Exhibit-B Pricing:** Revise pricing to reflect no greater than a 3% increase in fees as defined by Contract section 17A, "Fees and Charges" limiting the increase to "...the lesser of three percent (3%) or the annual increase in the Consumer Price Index for All Urban Consumers (CPI-U), U.S. City Average, All Items, Not Seasonally Adjusted, as published by the Bureau of Labor Statistics of the Department of Labor {<http://www.bls.gov/cpi/home.htm>} for the effective date of the increase compared with the same index one {1} year prior."
2. **In accordance with Section 3.A Term and Termination:** this serves as notification that the Contract is hereby extended for an additional twelve (12) months beyond its current expiration date, with the new expiration date being July 6, 2025.
3. **Option for Further Renewal:** Following this extension, the Contract will be eligible for one one-year renewal based on the terms and conditions of the Contract.

The changes set forth in this Modification are effective immediately.

The foregoing is the complete and final expression of the agreement between the Supplier and VITA to modify the Contract and cannot be modified, except by writing signed by duly authorized representatives of both parties.

**ALL OTHER TERMS AND CONDITIONS OF THE CONTRACT REMAIN UNCHANGED.**

PERSONS SIGNING THIS MODIFICATION ARE AUTHORIZED REPRESENTATIVES OF EACH PARTY TO THE CONTRACT AND ACKNOWLEDGE THAT EACH OF THE SUPPLIER AND THE COMMONWEALTH AGREES TO BE BOUND BY THE TERMS AND CONDITIONS OF THE CONTRACT.
