

MODIFICATION NO. 03
TO
CONTRACT NUMBER VA-210625-AAV
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
Acuity Audio Visual, Technology, and Leasing Consultants

This Modification **No. 03** ("**Modification**") is an agreement between the Virginia Information Technologies Agency ("**VITA**"), pursuant to § 2.2-2012 of the *Code of Virginia* and on behalf of the Commonwealth of Virginia ("**Commonwealth**") and **Acuity Audio Visual, Technology, and Leasing Consultants** ("**Supplier**"), to modify and amend Contract No. **VA-210625-AAV** ("**Contract**") in accordance with the terms and conditions of this Modification. This Modification and any attachments thereto is, upon execution by VITA and Supplier (each a "**Party**" and, collectively, the "**Parties**"), incorporated into and made an integral part of the Contract.

Capitalized terms used in this Modification have the meaning ascribed to them in the Contract unless otherwise defined in this Modification.

In consideration of the recitals set forth above, which are hereby restated and agreed to by the Parties, and for valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Parties, Supplier and VITA agree to amend the Contract as follows:

- 1. Extension of Contract Term:** The Contract term, currently scheduled to expire on July 6, 2026, is hereby extended for an additional one-year term through July 6, 2027.

This extension is intended to ensure continuity of services while VITA completes successor procurement activities.

This Modification does not establish any precedent or obligation for similar treatment in future modifications.

This Modification is effective upon execution by both Parties.


