

**MODIFICATION NO. 01**

**APPLIED TECHNOLOGY SERVICES**

This Modification No. 01 ("**Modification**") is an agreement between the Virginia Information Technologies Agency ("**VITA**"), pursuant to § 2.2-2012 of the *Code of Virginia* and on behalf of the Commonwealth of Virginia ("**Commonwealth**"), and Applied Technology Services ("**Supplier**"), to modify and amend Contract No. VA-230420-ATS ("**Contract**") in accordance with the terms and conditions of this Modification. This Modification and any attachments thereto is, upon execution by VITA and Supplier (each a "**Party**" and, collectively, the "**Parties**"), incorporated into and made an integral part of the Contract.

Capitalized terms used in this Modification have the meaning ascribed to them in the Contract unless otherwise defined in this Modification.

In consideration of the recitals set forth above, which are hereby restated and agreed to by the Parties, and for valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Parties, Supplier and VITA agree to amend the Contract as follows:

1. **Adding New Product Category to Exhibit-B Pricing** – Adds the ability for Supplier to sell ProHawk AI to the current product categories listed in Exhibit-B Pricing. ProHawk AI is a solution is a video artificial intelligence platform that works in conjunction with existing CCTV cameras to enhance the overall video clarity during playback. The ProHawk AI solution eliminates all of the anomalies that exist from poor cameras, environmental conditions, etc. ProHawk AI does not remove data from the Commonwealth network and thus does not require COVRAMP.

The changes set forth in this Modification are effective immediately.

The foregoing is the complete and final expression of the agreement between Supplier and VITA to modify the Contract and cannot be modified, except by writing signed by duly authorized representatives of both parties.

**ALL OTHER TERMS AND CONDITIONS OF THE CONTRACT REMAIN UNCHANGED.**
