

MODIFICATION NO. 03

CONTRACT NUMBER VA-240110-SECO
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
SECOM SYSTEMS, INC

This **Modification No. 03** ("**Modification**") is an agreement between the Virginia Information Technologies Agency ("**VITA**"), pursuant to § 2.2-2012 of the *Code of Virginia* and on behalf of the Commonwealth of Virginia ("**Commonwealth**") and **Secom Systems Inc** ("**Supplier**"), to modify and amend Contract No. **VA-240110-SECO** ("**Contract**") in accordance with the terms and conditions of this Modification. This Modification and any attachments thereto is, upon execution by VITA and Supplier (each a "**Party**" and, collectively, the "**Parties**"), incorporated into and made an integral part of the Contract.

Capitalized terms used in this Modification have the meaning ascribed to them in the Contract unless otherwise defined in this Modification.

In consideration of the recitals set forth above, which are hereby restated and agreed to by the Parties, and for valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Parties, Supplier and VITA agree to amend the Contract as follows:

1. Revision to Exhibit B – Pricing -

This Modification updates Exhibit B – Pricing to revise Product SKUs and Product Descriptions, and to remove discontinued or manufacturer-end-of-life (EOL) products and associated SKUs that are no longer commercially available.

No changes to awarded pricing, discounts, or pricing methodology are made as part of this Modification.

All remaining SKUs in Exhibit B continue to represent the complete and authorized catalog available for ordering under the Contract.

The changes set forth in this Modification are effective immediately.

The foregoing is the complete and final expression of the agreement between the Supplier and VITA to modify the Contract and cannot be modified, except by writing signed by duly authorized representatives of both parties.

ALL OTHER TERMS AND CONDITIONS OF THE CONTRACT REMAIN UNCHANGED.

PERSONS SIGNING THIS MODIFICATION ARE AUTHORIZED REPRESENTATIVES OF EACH PARTY TO THE CONTRACT AND ACKNOWLEDGE THAT EACH OF THE SUPPLIER AND THE COMMONWEALTH AGREES TO BE BOUND BY THE TERMS AND CONDITIONS OF THE CONTRACT.
